





Ancillary Meeting Space must be requested by February 7, 2024. MDA does not guarantee meeting space.

#### Photography & Videotaping Policy

Because of the sensitive nature of many of the sessions and presentations, videotaping and photography are strictly prohibited during all sessions of the 2024 conference, including general sessions, breakouts, keynote address, poster sessions, Industry Forums, and receptions. Photography is allowed only in your own exhibit space and cannot include any neighboring booths or conference attendees.

#### **Badges**
